

ARTICLES OF INCORPORATION

OF

CENTER FOR LOCAL GOVERNANCE EXCELLENCE FOUNDATION INCORPORATED

(Formerly ISAIAS C. UBANA EDUCATIONAL FOUNDATION INC.)

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the republic of the Philippines.

THAT WE HAVE HEREBY CERTIFY:

Article I: The name of the said association shall be:

CENTER FOR LOCAL GOVERNANCE EXCELLENCE FOUNDATION INCORPORATED

(As Amended on May 1, 2015)

Article II: That the purpose or purposes for which such association is incorporated are:

- 1. To conduct trainings, seminars, conferences and symposia for continuing professional and non-professional education for individuals and public/private organizations or institutions;
- 2. To undertake surveys and research for academic and non-academic purposes;
- 3. To enter into agreements, undertakings and collaborations with local and international public and private corporations including educational institutions to undertake programs, projects and activities for local governance excellence and other concerns;
- 4. To provide technical, management, legal and consultancy services to individuals and local government units (LGUS's) for local governance matters;

- 5. To provide financial assistance by way of a Scholarship Program to qualified tertiary and post-graduate students in public and private education institutions from part of the income of the corporation;
- 6. To provide by way of donation to Beata Sai Integrated School Incorporated or its successor part of the income which this Corporation may obtain as an incident to its operation;
- 7. To receive donations, property and cash assistance from local and foreign sources to finance its operations and programs:
- 8. To purchase real property, equipment, vehicles and appliances for the utilization of the corporation for the realization for the afore-mentioned purposes;
- 9. To give recognitions, awards and citations to individuals and groups for best practices in local governance;

(As Amended on May 1, 2011)

Article III: That the place where the principal office of the association is to be established is at:

240 Don Gregorio Yumul St., Brgy. Burgos, Lopez, Quezon

Article IV: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of incorporation.

Article VII: That the total contributed capital of the association is One Million Pesos Only (Php 1.990.000.00) contributed by the incorporators, trustees and members.

Article VIII. That no part of the income which the association may obtain as an incident to its operation shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code of the Philippines on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.

Article IX: That Fren V. Paraiso has been elected by the subscribers as Treasurer of the association to act as such until his successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the association, all contributions and donations to the association.

Article X: That the incorporators and trustees undertake to change the name of the association immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that name has been declared as misleading, deceptive, confusingly similar to a registered name, or contrary to public morals, good customs or public policy.


