AMENDED

ARTICLES OF INCORPORATION

OF

FOUNDATION FOR INNOVATION AND STRATEGIC LEADERSHIP INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned incorporators, all of legal age and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit association under the laws of the republic of the Philippines.

THAT WE HAVE HERBY CERTIFY:

Article I: The name of the said association shall be:

FOUNDATION FOR INNOVATION AND STRATEGIC LEADERSHIP INC.

Article II: That the purpose or purposes for which such association is incorporated are:

- 1. To conduct trainings, seminars, conferences and symposia for continuing professional and non-professional education for individuals and public/private organizations or institutions;
- 2. To undertake surveys and research for academic and non-academic purposes;
- 3. To enter into agreements, undertakings and collaborations with local, national and international public and private corporations including higher educational institutions to undertake programs, projects and activities for local governance excellence, innovations and other concerns;
- 4. To provide technical, management, legal and consultancy services to individuals and local government units (LGU's) for local government matters;
- 5. To provide financial assistance by way of a Scholarship Program to qualified tertiary and post-graduate students in public and private education institutions from part of the income of the corporation;
- 6. To provide by way of donation to Beata Sai Integrated School Incorporated or its successor part of the income which this Corporation may obtain as an incident to its operation

- 7. To receive donations, property and cash assistance from local and foreign sources to finance its operations and programs;
- 8. To purchase real property, equipment, vehicles and appliances for the utilization of the corporation for the realization for the afore-mentioned purposes;
- 9. To give recognitions, awards and citations to individuals, local government units, national agencies and groups for best practices in local governance;
- 10. To sue and be sued in its corporate name;
- 11. To engage in printing publishing, distribution and dealership of instructional, educational, technical books, articles, materials and devices to various national, local government units, public agencies, private corporations and civic organizations;
- 12. To provide consulting, technical and advisory services to persons, associations, corporations, partnerships and other entities, national and local government units in the filed of science, cultural, social welfare, research, educational, character-building, youth and sports development, health and to hire the services of professionals in the furtherance of the corporate purposes;
- 13. To provide national, local government units and private organizations/corporations with various technologies involved in processing and transmitting information which include computing, multimedia, telecommunications microelectronics and their interdependencies, engaged in software development, systems integration, content development for multimedia or internet purposes and supply infrastructures and other support facilities as required;
- 14. To engage in income-generating activities that are necessary or incidental to the statutory objectives of the Foundation.
- 15. To exercise such other powers as may be essential or necessary to carry out its purpose or purposes as stated in the articles of incorporation;

Article III: That the place where the principal office of the association to be established is at:

Lot 21-B Block 14 Iris St. West Fairview Quezon, City (As Amended on November. 8, 2018)

(Formerly: Room 106 PSSC Building, Commonwealth Ave., Diliman, Quezon City, 1101 Metro Manila)

Article IV: That the term for which the association is to exist is fifty (50) years from and after the date of issuance of the certificate of the incorporation.

Article V: That the names, nationalities, and residences of the incorporators of the association are as follows:

Article VII: That the total contributed capital of the association is <u>One Million Pesos</u>
Only (Php 1,000,000.00) contributed by the incorporators, trustees and members.

Article VIII: That no part of the income which the association may obtain as an incident to its operations shall be distributed as dividends to its members, trustees or officers subject to the provisions of the Corporation Code of the Philippines on dissolution. Any profit obtained by the association as a result of its operation, whenever necessary or proper shall be used for the furtherance of the purposes enumerated in Article II, subject to the provisions of Title XI of the Corporation Code of the Philippines.

Article IX: That <u>Perm V. Paratso</u> has been elected by the subscribers as Treasurer of the association to act as such until his successor is duly elected and qualified in accordance with the by-laws; and that as such Treasurer, he has been authorized to receive for and in the name and for the benefit of the association, all contributions and donations to the association.

Article X: That the incorporators and trustees undertake to change the name of the association immediately upon receipt of notice or directive from the Securities and Exchange Commission that another corporation, partnership or person has acquired a prior right to the use of that name or that name has been declared as misleading, deceptive, confusingly similar to a registered name, or contrary to public morals, good customs or public policy.

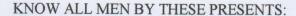
